James Lindsey Smith was born into bondage in Heathville, Virginia. Trained as a shoemaker, he and two others escaped from enslavement in 1838. Crossing the Chesapeake Bay in a small boat, they made their way to New Castle, Delaware, where they took a steamboat to Philadelphia. There, local abolitionists sent Smith to David Ruggles, formerly of Norwich, CT, a conductor on the Underground Railroad in New York City. Ruggles arranged for Smith to stay with noted abolitionist, Rev. Samuel Osgood, a Congregational minister in Springfield, Massachusetts.

After attending Wesleyan Academy in Wilbraham, Massachusetts, Smith married Emeline M. Platt, and settled in Norwich, Connecticut, in 1842. In his extraordinary *Autobiography*, published in 1881, Smith described his childhood enslaved in Virginia, his harrowing escape, his life in Massachusetts, how he established his business and bought the **59 School Street** property, and then his purchase of the **16 Oak Street** house, where he and Emeline raised their family. He detailed the struggles he faced and the support he received while living in Norwich, as he became a leader in his community, not only as a businessman operating a boot and shoemaking business, but also as a minister in the local Methodist Church.

(1) The house located at **59 School Street**, in the historic Jail Hill section of Norwich, is the first home purchased by James Lindsey Smith. In his *Autobiography,* Smith described with pride the purchase of this house three years after relocating from Springfield, MA, to Norwich:

The next year I had accumulated money enough to pay one-half for a frame house -- only a few steps from where I then lived -- before taking possession of it. Three years from this time I paid off all the mortgage on the house; then I truly felt that it was my own, since through my energy and toil, I had gained it.

Smith and his family lived in this home from 1845 to 1857, when he purchased a larger one located at 16 Oak Street in Norwich. He explained:

As the years rolled on my family began to increase, so I deemed it necessary to procure a larger house. Having made several attempts I bought a desirable one on Oak Street.

(2) Smith purchased house located at **16 Oak Street** in 1857, but the need for a new home did not come without problems as he and his family faced discrimination:

After a struggle of a few years, we moved into our new home. Reader, you must not think that I obtained it without any trouble. Ah! no; it was under difficulties; I had many a heart ache: I was persecuted on every hand for getting a home. While many would be encouraged for their industry and toil, my people are subject to all sorts of abuse for buying desirable homes for their families.

Smith and his wife, Emeline, lived here for the rest of their lives, and Smith spent his later years writing his *Autobiography*, in which he accurately and poignantly describes his life, especially in Norwich, Connecticut. James Lindsey and Emeline are both buried in unmarked graves in Yantic Cemetery in Norwich.

#### Is there any additional information that the Committee should be aware of?

Smith's son, James H. Smith married Lucretia Quy (whose ancestor, Lebbeus Quy, fought in the American Revolution) and continued his father's boot and shoemaking business in Norwich. Both James H. and Lucretia are buried in the City Cemetery, not far from the Oak Street house. Smith's daughters all eventually moved to Washington, D.C. where two of them, Lucinda A. Smith and Emily J. Smith taught in the freedmen's schools after the end of the American Civil War. Lucinda became principal of the J.R. Giddings School, the first public school in D.C. dedicated to educating African Americans. Copies of Smith's riveting *Autobiography* are available locally and online.






