This is to confirm the subject of our several discussions and your quote of June 23, 1997. Our final order is for 11 "salt and pepper" granite posts with dimensions of 7 inches by 7 inches by 7 feet, rough cut on three sides.

The posts require mounting of a 6 inch by 6 inch bronze plaque on the face of the least rough side exactly 3 inches down from the top of the post. Special epoxy and brass screws and grommets will be supplied by us when the plaques are delivered to you for mounting.

Only 9 of the posts actually require plaques and subsequent placement at the historic sites in Farmington Village. All sites are in close proximity (within a mile or so essentially along Main Street). There will be stakes in ground at the exact locations. A member of the Farmington Historical Society - probably myself - will be on hand for the installations.

The posts must be sunk and leveled 42 inches <sup>in</sup><sub>A</sub> ground leaving 42 inches showing above ground.

The two remaining posts can be delivered to a local address to be provided later. As mentioned, nothing else will be required for these two posts.

The Society will purchase the eleven posts and a copy of our non profit status permit from the State is attached for your information. May we please have an invoice indicating the total cost based on the new information above (plaque mounting and installation of 9 posts and delivery of 11).

Also, may I please have the name and phone number for the gentlemen who will install the posts. We ask that these be installed as soon as possible on or after August 18. (my tel. 860 677 2870).

Finally, for your information I will forward a copy of this and the June 23 quote/estimate to the Connecticut State Historic Commission which is coordinating the many Freedom Trail site activities around the state in case they may wish to advise others of your product.
